



## John Francis Galligan

John Francis Galligan, (Jack), 85, died January 25, 2024 at South County Hospital after a short illness in the arms of loving husband and best friend Andrew Wade Mack of 50 years. Born June 17, 1938, the only son of the late Henry Francis Galligan and Margaret Mary (Thurber) Galligan. He was predeceased by his sisters Frances Young, Peggy Galligan and Karen Galligan all of Cranston. Left to cherish his memory are his sisters Patricia Abbruzzese and Mary Forgue of Cranston, along with his special nephew Patrick Thibadeau and best friend Richard Place, along with nephews Richard Young, Robert Young, Steven Young, Joseph Forgue, Michael Forgue, Paul Forgue, Raymond Forgue and a niece Rosemarie Abbruzzese with many friends and associates of a life well lived. Jack was born in Providence, RI, grew up on the Amity Street of Providence where he attended the church as a young boy and was the ringer of the church bells. The family later moved to Blackamore Ave in Cranston, RI where Jack and his five sisters grew into their teenage years. Jack attended La Salle Academy, where shortly after graduation he was drafted and served in the US Army. He was stationed in New York City, honorably discharged, Jack returned home and started his long career as a Public Servant with State of RI. Jack was the co-founder and the first President of the Brotherhood of Correctional Officers Union (ACI), President of the local 528 ASFCME Union at the University of RI, Executive Board of Council 94, later Executive Board of ASFCME Chapter 94 RI retirees, he also served many years on the Rhode Island Retirement Board.

He was a past member of the Mt. View Association of North Kingstown, a member of the Quonset Davisville Navy Yacht Club at Allen Harbor in North Kingstown, Captain of his boat " The Lord Jim". After retirement, Jack enjoyed a long and happy life with good friends, neighbors, fishing and sailing on Narragansett Bay. A Memorial Service to honor his life to be planned at a later date.
